Today I was informed by our District Office that the appeal you lodged through the membership service section of the NSW RFS has been upheld and reinstated, therefore your membership continues with the brigade. However as you are aware your Deputy Captain role within the brigade has since be removed from the brigade register, as I am aware as per your Facebook message this morning it has been addressed however needs the Team Manger Mr Paul Jones to approve before this can be adjusted so I ask that you please be patient during this time.

As for the comments of your Facebook and negative thoughts towards the brigade executive committee I would like to clear the water and make it perfectly clear that it was never the Brigade Executives decision weather your membership was reinstated, nor was it a personal attack towards you. Mark and Myself were simply following the directions of the district staff and Team Manager.

I have attached the Service Standard 2.1.6 Joining the NSW RFS as a Volunteer Member (including Transfer Applications) for your information regarding you feeling you shouldn't be classed as a reserve member.

Section 1.3

(D) Reserve: a member whose participation is infrequent but is available for operations and operational support roles during major incidents. Depending on the role firefighting qualifications and experience may be required;

All members who have not met these requirements set out in the brigade active test have been listed as Reserve. This allows the brigade executive to monitor who is "active" and who is "non-active".

case, I do not have negative thoughts of the executive as a whole at all.

Can I request the executive review the assumption that the definition that has been applied to determine reserve members if actually being applied correctly.

Reserve: a member whose <u>participation is infrequent</u> but is <u>available for operations</u> and operational support roles <u>during major incidents</u>. Depending on the role firefighting qualifications and <u>experience may be required</u>;

The clear distinction here is " is available for operations and operations support roles during major incidents".

There is no distinction in the definition that simply allows a member to be classed as reserved for merely being infrequent, the description requires both the member to be infrequent but only available during major incidents only.

The fact is that I have been available and attended normal non major incidents as recently as last month.

In comparison the definition of an active member has no time commitment requirement and simply requires the member to meet qualification requirements, be considered a fire fighter and be issued PPE which are all applicable in my instance.

<u>Active</u> Members that have <u>firefighting qualifications and/or recognized experience</u>. This classification includes <u>members who are firefighters</u> and members who fulfil specialist roles or support roles. For example: Firefighter, Air Base Operations, Field Communications and Catering, and other <u>members who fulfil a role that requires PPE.</u>

I am not certain the application of reserve status to members has been completed accurately and I am not sure there is sufficient visibility or in fact clear measures used when deciding who is a reserve member and who is not, what you don't understand is my concern is driven by the fact that placing members on reserve status affects their Ability to use that time for counting toward long service or service records, this is the issue I had to recently deal with and get rectified, I have been a member of the RFS since 1997 but some brigades had recorded me as reserve incorrectly, this prevented several years of my service being able to be counted towards long service until I was able to get it repaired.

Placing people on reserve incorrectly will impact their ability to count their service toward service medals or recognition.

It does not impact me (I'm operational in another brigade) as much as the other members who I have been told you have put on reserve and I think it's important for me to raise this.

As for the Brigade Constitution there is only particular avenues that would affect you being a "active" or "non-active" member nothing that would effect your role / rank within the brigade. I wish to advise you that as you appealed the decision to transfer and have it show that you'll now be classed as a dual member there is no requirement from you to complete a probation period.

Due to the frustration and trouble that is required to get my DC Position reinstated and following a decision from the Acting team manager that the reserve membership status placed upon me by the brigade executive (or members there of) voids my deputy's position i am no longer seeking to have my position reinstated.

I am extremely disappointed that I am the first Deputy that this has happened to regardless of others having previously been in the same position as me, yet their membership status was never changed to reserve at all over numerous months and years allowing them to hold their negitive the

I am not convinced that opportunistic efforts were not taken to construct this outcome and don't feel that it will be in my interest to be part of the field positions any longer if such efforts did in fact occur, if i cant trust the other officers then its not worth the effort.

I am bitterly disappointed that an honest mistake on my behalf has lead to this and more so that my previous efforts seem to count for nothing

A few facts have me highly suspicious of what has occurred.

- 1) I mentioned on facebook that i had made a mistake my access to the members page was removed without notice within 12 hours.
- 2) I was removed from the SMS call out process without notice.
- 3) Within 8 hours of my notifying brigade management that my membership had been reinstated and supplying a screen shot showing i was active, a review was conducted (the first i am aware of occurring since i joined the brigade, very unlikely to be coincidence) that moved me to reserve and made my deputy's position void.

This has never happened to other officers in periods of low activity, the brigade has even given some other officers awards for their low attendance at xmas party's without reviewing their active status.

4) I was advised that i would have to reapply and most likely would not be accepted due to the ten kIm rule when i initially notified management of my mistake which was not correct.

I will post my authority card back to the office this week, i do not want a response to this email, i am over the bull shit that has been created around a simple mistake and after receiving the outcome of my application to be reinstated which stated that now as a reserve member i am not active and thus not able to hold a DC position. there is no point continuing of with this matter.

I am done.
